## AGREEMENT

**THIS AGREEMENT** is entered into by and between SaveCaSchools.org, a California nonprofit corporation [referred to hereafter as “Corporation”], and \_\_\_\_\_ [referred to hereafter as “donor”], collectively referred to hereafter as the “parties,” on the date indicated below. Unless terminated earlier for cause, as defined herein, this Agreement will remain in effect for a period of one year.

Corporation is a nonprofit organization organized under the general corporation laws of the State of California, and deemed to be “non profit” pursuant to section 501(c)(3) of the Internal Revenue Code. The general purpose of Corporation is to assist public schools in the State of California by collection donations from persons and entities who share a desire to donate monies to help educate the children of California.

Donor has donated the sum \$100.00 to Corporation. In consideration of this donation, donor has received a receipt acknowledging the donation, will receive a certificate which may be proudly displayed evidencing the donation, and a public acknowledgment on a website developed and maintained by the corporation.

**Termination for Cause.** The parties acknowledge that it is important to both the public school systems who receive the donations, and Corporation which distributes monies to the public school systems, that Corporation maintain a proper public image. It is anticipated that many donations made by the Corporation may receive public attention, potentially resulting in public scrutiny of the Corporation, its membership, and those who or which support its charitable activities. For this reason, donor agrees to refrain from any conduct, public or private, which could prove embarrassing or otherwise discredit Corporation and its membership. It is further agreed that Corporation may, without notice or appeal, remove donor’s name from its website, and prohibit any future participation, should any of the following events occur:

1. If an individual, being convicted of a felony, or any crime involving moral turpitude, including but not necessarily limited to theft, extortion, embezzlement or fraud;
2. If a business entity, suffering the loss of its privilege to conduct business in the State of California, or any officer, director or principle shareholder being convicted of a felony, or any crime involving moral turpitude, as defined in paragraph 1.,above;
3. Any license issued to the donor, other than a license to operate a vehicle or aircraft, or a government issued license for hunting or fishing, if suspended or revoked due to misconduct; or
4. If donor, or any independent contractor, employee, agent or representative of donor, increases any fee otherwise due him/her/it from a customer or other person or entity with the intent that said additional monies would “cover” the amount to the donated under this Agreement.

The parties, having read this Agreement, and desiring to be bound hereby, freely and voluntarily enter into this Agreement by affixing their signatures below. This Agreement is entered into the County of Contra Costa, and shall be interpreted under California law.
